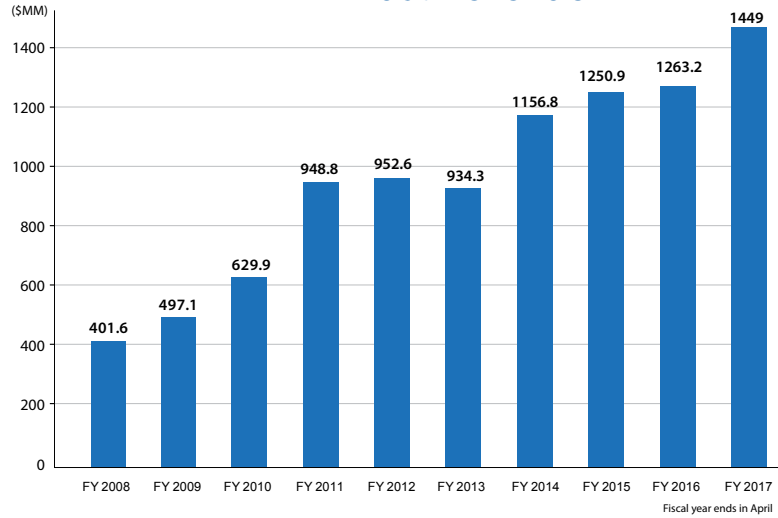

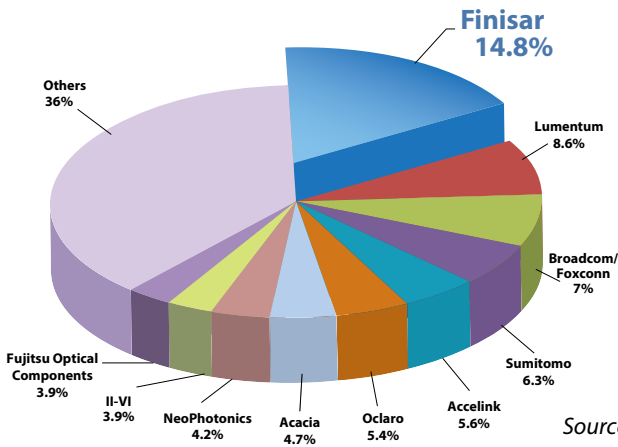

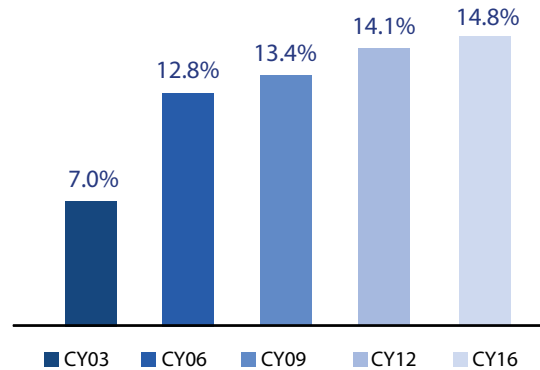
Annual Revenue
